Children under 6 years of age travel free of charge. Swiss Family Card not required.

Children from the age of 6 up to their 16th birthday but not accompanied by at least one parent, receive a 50% discount off regular prices of the Swiss Travel Pass and Swiss Travel Pass Flex.

## Entitlement

Maximum one (1) AD75 ticket per person per year for:

- **Group A:** IATA / non-IATA travel agents: agent (plus 1 accompanying person).
- **Group B:** Switzerland Tourism staff (plus 1 accompanying person); SWISS staff (plus 1 accompanying person). Swiss embassies and consulates: staff (plus 1 accompanying person).

**No entitlement: staff of external agencies, event groups, special groups or third parties (for example, advertising agencies, etc.).**
